Applications are invited through walk-in interview for the post of Registrars/Demonstrators from PSC/Non-PSC doctors who are permanent residents of J&K state, for the tenure posts of Registrars/Demonstrators in various disciplines of this college for a maximum period of three years as per SRO-25 of 2013 dated 28-01-2013. Walk-in interview will be held on 15th of July 2019 at Mahatma Gandhi Hospital, Govt. Medical College, Kathua) as per following schedule:

Report time for interview: 10:30 AM

Verification of documents: 11:00 AM

Timing of interview: 12:00 noon

TERMS AND CONDITIONS

A. For in-service PSC candidates

1. The in-service doctor shall be paid salary as per their LPC.
2. In case of selection, they will be allowed to join only after getting relieved from their administrative department.
3. The candidate must have put in two years of service in health department to be considered for the post.
4. In case of selection, they will be allowed to join only after getting relieved from their Administrative Department.

B. For candidates who are not in government service (NON-PSC) candidates

1. The Non-PSC doctors shall be engaged on consolidated pay equal to basic pay for the post of Assistant Surgeon in the Health Department as per SRO-93 dated 15-04-2009 plus Dearness Allowance.
2. Maximum age for eligibility to apply shall be 50 years as on cut-off date.

C. The list of documents to be produced at the time of walk-in interview:

1. Attempt certificate of 1st, 2nd, pre-final and final MBBS examination issued by the concerned university.
2. MBBS, MD/MS Degree/Diploma in concerned subject (MD, MS candidates will be preferred).
3. Internship completion certificate.
4. Service certificate (clearly indicating rural service, if any) issued by the director, Health Services, Jammu/Kashmir in respect of in-service doctors.

5. Distinction/National scholarship/Honours/Medals/Academic merit certificate.
6. House job certificate(Sr/|r) issued by the concerned principal or equivalent, recognized authority.
7. Professional publications in a MCI permitted indexed standard medical journals, if any.
8. Date of birth as per matriculation certificate.
9. Permanent resident certificate.
10. Affidavit duly attested by the Judicial Magistrate declaring that the applicant has not done Registrarship/Sr. Residency earlier within or outside the J&K State.

The selection of the candidates will be made on the basis of combined academic merit and performance in the interview as per the rules/order issued by the State Govt.

Vacancies are available in the discipline of Microbiology, Anaesthesia, Orthopaedics, General Medicine, TB & Respiratory Diseases, Dermatology, Psychiatry, Paediatrics, General Surgery, Dentistry, Radiotherapy and Radio-Diagnosis.

No TA/DA will be admissible for appearing in the interview.
